# **Policy Area-Specific Questions:**

In a poll of our members, Housing, Transit, and Homelessness were our top policy priorities.

#### HOUSING

14. California's Regional Housing Needs Allocation (RHNA) mandates that San Francisco construct 82,069 new residential units between 2023 and 2031. In 2023, SF approved 1,136 unit permits, falling far short of the 9,118/year needed to meet our housing goals.

a. What do you perceive to be a bottleneck to the permitting and construction process and what do you propose to accelerate our local permitting process for both affordable and market-rate projects? What are your thoughts on the recent implementation of <u>SB 423</u> (Wiener, 2023) in San Francisco?

**Ellen:** Many people do not understand that San Francisco has NOT had a People government for many years. Most of these policies are for "show", with no benefits to the residents who need help. Agenda 21 failed, and now the deep state is working on Agenda 2030, learn more about the truth: <a href="https://timetofreeamerica.com/">https://timetofreeamerica.com/</a> As of July 2024, SF has more than 75,00 empty apartments available, 37% businesses closed, 36% empty buildings, why do we worry about housing when we have so many empty apartments and buildings? Remember, we don't have a People government right now, only deep state players. When I am in the Mayor's office, I will work with building owners to release all these empty buildings and apartments and create policies to benefit owners, businesses, and residents.

b. Do you support ending the <u>RH-1 zoning designation</u> of single-family homes in favor of establishing sixplex multi-family residential buildings as the city-wide minimum residential density? Do you support the proposed <u>SF Housing Element plan</u> to increase housing density?

**Ellen:** SF has limited land, 7 by 7 miles, we can re-evaluate our land use and availabilities before deciding on either high-rise buildings or single-family homes. Our population is different than 100 years ago or 50 years ago. But I don't support a 15-minute city for the One World Order government. We can build homes according to residents' needs. It depends on location, we can either build complex family homes or high-rise buildings. If we have the space and the need, we build according to demand.

c. Do you support increasing residential density within ½ mile of major public transit stops or high-quality transit corridors? If so, to what extent?

**Ellen:** Yes but It depends on the needs of the population. It is good to build housing that needs public transportation, create recreational parks, supermarkets, and libraries, and make it a self-contained community where people love to hang out with each other.

15. Do you support converting any of our <u>six public golf courses</u> to be zoned for low-income housing? If so, which golf courses would you convert and how many residential units would you propose building? If not, why?

**Ellen:** Again, we have to utilize all these empty buildings and apartments first. We don't lack housing in SF. But we lack affordable housing. Affordable housing means paying no more than 30 % of total income. I don't know the whole picture until I have a public survey and public hearing from local communities and families.

**Ellen**: Both property owners and residents should be equally protected. Our current government leaders have NOT been able to follow the US Constitution to run our republic form of government. So the answer becomes a question: why should the government keep on bullying hardworking property owners for rent or higher taxes? When is the benefit of rent control or free market? ### PUBLIC TRANSIT AND ACTIVE TRANSPORTATION

- 19. What is your primary mode of transportation?
  - a. How often do you take public transit and how often do you ride a bike or other form of micromobility (scooter, skateboard, etc.)?

**Ellen:** I usually drive and occasionally take Muni.

b. If you own a car, how often do you use it?

Ellen: I drive my car as needed.

c. What barriers may prevent you from taking public transit or using micromobility more often/at all?

**Ellen:** I have to take Muni when I know places where is hard to have parking or expensive parking.

- 20. Since the pandemic, both MUNI and BART have faced structural operational budget deficits due to reduced fare box revenue. Without additional operational funding, BART will be forced to make major service cuts, resulting in significant transit worker layoffs and scenarios including the end of weekend service, termination of an entire BART line, or multiple station closures. MUNI will be forced to gradually end the service equivalent of 15-20 bus lines.
  - a. What new funding mechanisms do you propose to alleviate these budget shortfalls in both the short term and the long term?

**Ellen:** My understanding our public tax dollars are enough to run our government function. But the deep state abuses and corrupts our \$\$\$ money for their political gain with people they know. If you audit incomes and expenses, you will know things don't add up. As a new Mayor, I will audit public books and accounts, and trace the money back, everyone should be able to ride Muni or BART without hardship. b. Do you support <u>SB 532</u> (Wiener, 2023/24), which would temporarily increase Bay Area bridge tolls by \$1.50 from January 1, 2024, through December 31, 2028, to prevent major near and medium-term service cuts that agencies around the Bay Area, including but not limited to MUNI and BART, are facing, until additional long-term, sustainable transit operating revenue sources are identified?

- 26. SF's BayWheels bike share program has the highest user fees of any bike share program in the United States. Do you support appropriating an additional \$5 million dollars from

the General Fund General Reserve to the operational budget of the Baywheels bike share program to lower the cost of use for one-time rides and annual memberships? If not, why?

- a. Would you support financing a city-owned and operated bike share program (as they have in Montreal) in lieu of a privately owned and privately operated bike share program (as we have in SF today)?
- b. Do you support adding additional Baywheels stations in neighborhoods where a network gap currently exists? *This question can be a yes or no response. If you'd like to elaborate, we encourage you to do so.*
- 27. If you were appointed to represent San Francisco on the Metropolitan Transportation Commission (MTC), would you support an integrated transit fare structure for the Bay Area's 27 different transit agencies as outlined in SB 917 (Becker, 2022)? If so, how?
  - a. Would you support creating a monthly pass for unlimited 9-county-Bay-Area transit system use, expanding upon the recently instituted <u>Clipper BayPass</u> pilot program?
- 28. The <u>SF Climate Action Plan</u> (2021) states that 47% of San Francisco's greenhouse gas emissions come from transportation (2.20 million mtCO2e). Of these total transportation emissions, 72% come exclusively from gasoline-powered privately owned vehicles (1.58 million mtCO2e).
  - a. How do you propose building electric vehicle charging infrastructure for individuals who park their EVs on the street?
  - b. Do you support a complete electrification of the City-owned vehicles? If so, what is your proposed timeline? If not, why?
  - c. Do you support timing stoplights to prioritize bike and pedestrian use rather than car use?
- 29. Do you support the removal of the remainder of the Central Freeway stub (the portion of US 101 that diverges from the Bayshore Viaduct near 9th/Van Ness and ends at Market and Octavia Streets) and replacement of the structure with a surface boulevard, transit and active transportation improvements, and increased housing? If not, why?
- 30. Are you in favor of expanding the use of Autonomous Vehicles (AVs) for ride-hailing services in San Francisco? If so, under what circumstances? If not, why?

### **HOMELESSNESS**

- 31. Do you believe we need to put additional funding into temporary shelters or permanent supportive housing?
- 32. How should the City streamline the construction of new Navigation Centers?
  - a. Do you commit to building a new Navigation Center within your district by the end of your first term? If so, where?
- 33. Would you support a bill similar to <u>SB 57</u> (Wiener, 2022) which would authorize the City and County of San Francisco, the County of Los Angeles, the City of Los Angeles, and the City of Oakland to approve entities to operate overdose prevention programs? If not, why?
- 34. Did you support <u>Proposition C in 2018</u>? Would you make any amendments to the allocations within the proposition as it was written?
- 35. Do you support <u>SB 43</u> (Eggman, 2023), which expands state conservatorship laws by lowering the legal standard for the City or the State to implement a conservatorship on an individual experiencing homelessness, by expanding the definition of "gravely disabled"?
- 36. Recently, the US Supreme Court decided in <u>Grants Pass v. Johnson</u> (2024) that people experiencing homelessness can be criminalized if sleeping outside, even if there are no shelter or housing alternatives available. Should SFPD be able to clear encampments of people experiencing homelessness? If so, under what circumstances?
- 37. Do you support reforming or repealing the Ellis Act (1985) and the Costa-Hawkins Rental Housing Act (1995)? If so, how would you modify these laws?
- 38. San Francisco's COVID-19 residential eviction moratorium for non-payment of rent ended on August 29, 2023. Do you support the end of this moratorium? If not, why?
  - a. Should any additional services be provided for affected individuals who are evicted as a result of the end of the moratorium?

If you were to modify the existing SF City Charter (effective as of July 1996 and written by Supervisor Barbara Koffman's committee which re-established district-based Supervisorial elections) in any way, how would you do so?
